
Dear Friends of Catholic Charities Bureau,



It all started in a meeting with Barron County UW-Extension where a group from the community were meeting to discuss the development of a "Community Garden." They were looking for a location, so BCDSI offered the group to look at a spot on the BCDSI property. It soon became one of three potential locations and ultimately was chosen for the site of the Barron Community Garden.

From the small group of volunteers who came together to build it, to the Master Gardeners who help maintain it, the relationships continue to grow. One of the people we serve, Mike, was in the first group to plant and maintain them until harvesting occurred. Each year, he looks forward to working in the dirt, talking to the other gardeners, and most of all picking the ripe produce.

Once the first harvest was in, donations from the two open plots used to grow produce for the Barron County Nutrition Program, proved to



provide more produce than they could handle. This led to connecting with four area food shelves who were very happy to get these donations. Now, an ADRC volunteer driver picks up the produce twice per week during the season and delivers the produce to the various food shelves. Mike volunteers at the Food Shelf weekly, and hand delivers the fresh produce.

Today, the garden has become a place where people plant and gather, as this year, it was one of the "Make Music Day" sites, hosting two performers. The garden donated almost two tons of produce through harvesting by BCDSI and Garden Volunteers this year. The garden has brought the community to BCDSI and in return, our efforts help feed the residents of Barron County.

Build. Respect. Inspire.



"You never know what your role is going to be the next time you come in our door", is a saying we use at BRI to remind each person to provide services in the best way possible. At BRI, we work very hard to ensure that each person in our community receives needed services in a way that is respectful and unique to them.

Several years ago, a family reached out requesting 24 hour services. Their son had been in a car accident years before that now impacts each day of his life. He needed this high level of care as he is now unable to communicate reliably, has limited memory, requires a wheel chair for mobility, and has limited movement. He desired independence and a girlfriend. We worked with the family to set up the first 24 hour apartment in our county. This has allowed him to be himself in his home and live as independently as possible. It has also expanded our services to offer more hours to other people in need in the area. This service from BRI has allowed his family to enjoy him as a family member. The family has utilized their time to enjoy trips with him and family gatherings. They also pay it forward by volunteering for Special Olympics and helping other families.

Providing service to this family has created a ripple effect for others in our area to receive needed services and for families to enjoy one another while making a difference in the community. Although we have not found him a girlfriend, we have given him his independence so that so many people in our community get to know him and understand that BRI is here to support everyone that needs to come through our door!

Joe has been coming to the Challenge Center since 2013. Joe resides in the Challenge Centers Harborview home. Joe has always expressed a desire to work in the community. He loves his job at UWS in the Chartwell's kitchen. But Joe did not start out working in the community. Joe spent his first few years in the Challenge Center Prevocational Program and working at Bay Produce. Here, he gained the skills required to be successful in the workplace. Joe applies the skills he's learned to become an important member of the Chartwell's staff. What may seem basic to most of us can become a serious roadblock to the daily functions of holding down steady employment. From providing daily transportation, clean work attire and encouragement, the Challenge Center Staff are there to lend a hand as Joe strives to live and work as independently as possible. Joe also has ongoing support from the Challenge Center in the form of a Job Coach.



The long ranging ripple effects of supporting Joe in his desire to work are many. The simple fact that Joe is able to go to work each day and earn a paycheck gives him the pride we all feel in holding down a steady job. The feeling Joe's family gets as they see him earn his own money and make his own choices gives them the assurance that he will be able to pursue the things that make him happy into the future. Chartwell's on the UWS campus gains a quality long term employee that brings a positive attitude to work each day.

The Challenge Center also assists Joe in his desire to have some fun each day. As a resident of the Harborview House, Joe has daily opportunities to not only interact with his housemates and staff, he is also supported in his desire to explore his interests and his community. In the time Joe has lived in Superior and the Harborview house in particular he has been encouraged to try new experiences and pursue the things in life that make him happy.

The ripple effects of Joe receiving services from the Challenge Center are definitely felt by his direct family members. Coming from a large family with six siblings across the country, the support and wellbeing of Joe is of paramount concern. Joe's mother is able to go to work each day confident in the knowledge that her son is able to pursue his goals.

It's difficult to highlight all the different effects the Challenge Center can have on a person like Joe. Perhaps the easiest way is to think of all the ways an active member of a community can affect that community. It's in the joy Joe brings to his co-workers and customers at work each day. It's in the excitement on his face when he tells his mother about how proud he is to go to work. It's in the fun and friendship he shares with others. It's in his interactions with neighbors and others as he goes through each day. The Challenge Center has been there to support Joe as he has developed into that active member of our community and will be there to support him into the future.

Recently, DSI expanded its services to include Community Day and Community Prevocational services. We received a call from a mother who had heard of the new programs DSI was offering. She contacted DSI to receive Community Day Services for her son Alan who had extremely limited mobility. A plan was quickly developed to serve him.

At the time we did not have a wheelchair accessible vehicle, so we contacted one of our sister agencies, Black River Industries an affiliate of Catholic Charities Bureau, who was able to loan us one of their busses. Modifications were made to the building including adding lifts and ramps to assist with his accessibility. Alan initially started in our program part time to see how it would go, but after a short period, he began participating in the program full time.

Alan's mother was a member of a volunteer group in Burnett County called "Mom's for Kids." We began partnering with that group at various events in the community. This led to the DSI Day program participating in the Mom's for Kids enrichment activities held at the Crooked Lake Park through the summer. This partnership continues to strengthen every year.

DSI is now awaiting the delivery of a new accessible bus, which will expand our ability to serve individuals in wheelchairs. Alan's family is very pleased with the services provided, especially seeing how much more Alan is able to participate in volunteering, community outings and building new friendships along the way.

Carol Anne has been coming to Headwaters, Inc. for 21 years. When we met her in 2002, she lived in a group home and wanted to live in her own apartment. We had the pleasure of assisting Carol Anne to live independently in her own apartment. Headwaters began the process by providing support to her and a roommate 24/7. Through her selfdetermination, hard work, and advocacy skills, Carol Anne has proven herself to be very successful and independent. She now lives

independently in her own apartment and continues to utilize a supported living coach weekly to support her with shopping, appointments, running errands, and daily living. Carol Anne participates in our Work Services program 3 days a week, where she is dependable, helpful, and sets a good example for her coworkers. Her favorite jobs are sorting, counting, and packaging feathers, chips, and soda on our production floor. She is working on skills to meet her personal goal of getting a job in the community. Carol Anne works with a Headwaters Employment Specialist towards her goal. To date, they have completed a job development plan, a resume, a cover letter, and have started the process of applying and interviewing for stocking positions in the local community.

Carol Anne says, "it's great" living in her own apartment". She knows she does not need staff all the time and is able to make her own meals, take her daily medications, and do her laundry (even though she doesn't like to do it). She is active in her local community and a firm believer in giving back. She attends weekly Zumba classes at the YMCA and enjoys shopping at the Dollar Tree. Carol Anne is active in her church and volunteers in the nursery. She enjoys helping in the community and at Headwaters, Inc. for special events and holidays. Most recently, she donated candy and prizes for the YMCA Halloween party and helped the kids 'trick or treat' at the church party. Carol Anne is a yearly volunteer at the Headwaters Foundation Golf Tournament, where she chooses winners for gift baskets! Carol Anne is appreciative of the support she receives and loves to help others.

We are so happy to work with Carol Anne on her goals to live and work in the community. She shares her joy and success with her family, the Headwaters community, and the local community she lives in! She exemplifies courage, determination, hard work, advocacy, and the spirit of giving back.

Hudson Community Children's Center has been in the same neighborhood for the last 50 years. We started at the corner of 4th and Orange in St. Paul's church basement. Five years later we moved a half block down the street and in 2007, HCCC moved once again to the other corner of 4th and Orange Street again. Although we have moved 3 times – it has all been within a half a block of our original location.



Being part of this neighborhood is in the DNA of this organization. We have always served families in this community. Through the years we have been close enough that a third of our population can walk to the Center. We have, at times, had a whole neighborhood in driving distance attend with as many as five families all living only a few blocks from each other. The children were friends or very familiar both at daycare and at home. This level of commitment to our enrolled families allows us to provide a feeling of safety in this neighborhood and causes a slow wave of connection with each other. We also have families that are so comfortable with our teachers and educational assistants that they request childcare outside of HCCC for their personal wellbeing.

At times Hudson Community Children's Center has been such a part of a family's life that we have had three generations receive care from us over the course of 50 years. Not only is this obligation true for our families but at the present time it is true for our staff as well. We have two generations working here with the third generation welcomed in our 4K classroom – our Cook and Ed. Assistant work here and the daughter of our Ed. Assistant is enrolled at HCCC. Over the years the Center has had many moms and children working and growing together, right now our 4K teacher and her daughter are a great example.

One last ripple effect of the caring nature of HCCC is the number of groups of parents that are willing to share their time and their talents with our students. This enriches not only our learners but also our staff and other families. As most parents will gladly tell you, Hudson Community Children's Center feels like home.

## Catholic Charities Bureau Assumes Ownership of Two Apartment Complexes



Centennial Apartments consists of six 2-story brick buildings each with eight 2-bedroom apartments for seniors and individuals with disabilities. The buildings are arranged around a large green commons, graced by a beautiful hand built gazebo. Catholic Charities Bureau has managed Centennial Apartments since 2009 and has since turned this complex into the place to be in Medford.


